# **Economic Overview of Nepal:**

Nepal's logistics industry faced various challenges such as insufficient infrastructure, difficult terrain, bureaucratic hurdles, and political instability. These factors often hindered the smooth movement of goods within the country and across its borders. However, efforts were being made to improve the situation. Initiatives such as infrastructure development projects, modernization of customs procedures and collaborations with neighbouring countries like India and China were underway to enhance the efficiency of logistics operations.

Nepal's air cargo industry faced challenges primarily due to infrastructure limitations and regulatory constraints. Nepal's geography with its mountainous terrain and lack of sufficient transportation infrastructure, posed obstacles to efficient cargo movement. Additionally, the industry fighting with issues such as insufficient handling facilities at airports and complicated customs procedures leading to delays and increased costs. Despite these challenges, there were efforts to improve the situation, including infrastructure development projects and initiatives to streamline processes.

Same as, Cargo industry by land, sea and rail transportation also faces significant challenges due to the country's landlocked geography. Land transportation primarily reliant on roads encounters obstacles such as difficult terrain, limited infrastructure and inconsistent road quality, leading to inefficiencies and delays. The sea cargo industry relies on neighbouring countries' ports which is adding complexities and costs to logistics. Nepal's rail cargo infrastructure is still in developing stages with limited connectivity and capacity. Despite these challenges, efforts to improve infrastructure, enhance trade agreements with neighbouring countries and promote regional cooperation may offer opportunities for growth in Nepal's cargo industry but significant investments and policy reforms are needed to realize its full potential.


# Nepal Foreign Trade Statistics:

Nepal's total international merchandise trade shows an increasing trend over the last five years excluding the abnormal period of Fiscal Year 2019/20 (FY 2076/77) and Fiscal Year 2022/23 (FY 2079/80). The government of Nepal imposed import restrictive measures in order to mitigate the pressure on the foreign exchange reserve. As a result, the import and export of goods declined in Fiscal Year 2022/23. The export of goods decreased by 21.44 percent to NPR 157.14 billion in Fiscal Year 2022/23 from NPR 200.03 billion in Fiscal Year 2021/22. Similarly, the import of goods decreased by 16.08 percent to NPR 1611.73 billion in Fiscal Year 2022/23 from NPR 1920.45 billion in Fiscal Year 2021/22. Consequently, the total foreign trade of goods decreased by 16.58 percent to NPR 1768.87 billion in Fiscal Year 2022/23 from NPR 2120.48 billion in Fiscal Year 2021/22. Despite this decrease in the import and export of goods, the trade deficit reduced to NPR 1454.53 billion in Fiscal Year 2022/23 from NPR 1720.42 billion in the previous fiscal year. There was also a significant reduction in the collection of customs revenues in Fiscal Year 2022/23 as compared to that of Fiscal Year 2021/22. The customs revenues of NPR 390.7 billion were recorded in Fiscal Year 2022/23, which is a 22.9 percent decrease from the NPR 506.42 billion of revenue collected in Fiscal Year 2021/22.



# Five Year Trend of Nepal's Foreign Trade:



Nepal's foreign trade took place with more than 170 countries and territories in Fiscal Year 2022/23 (FY 2079/80). However, the majority of its trade took place with its two neighbouring countries - India and China. India is the largest trading partner of Nepal – both in terms of import and export trade. Nepal's 64.14 percent of the total trade took place with India in the fiscal year 2022/23 (FY 2079/80). In addition, India accounted for 63.77 percent of Nepal's total import trade and 67.89 percent of its total export during this fiscal year. China is the second largest trading partner of Nepal constituting 13.09 percent of Nepal's total trade in Fiscal Year 2021/22 (FY 2078/79). In addition, Nepal's import trade with China (including Hong Kong and Taiwan) accounted for 14.22 percent and an export trade share of 1.49 percent in this fiscal year. Hence, China is not the second export destination. The United States of America stood as the second largest export destination for Nepal in Fiscal Year 2022/23 (FY 2079/80).

# Meeting with Major Port Authority of Neighbour Countries:

The NEFFA Team visited Rusuwa border and Kerung (China) border for the possibility of international import and export through that border. During the visit NEFFA Team met with the head of the Customs Office, Chief District officer, Nepal Intermodal Transport Development Committee, Security Agencies, various Industry and Commerce Association and CHAs at the Rusuwa and discussed the situation, possibilities and long-term plans of import and export through the border. The meeting help to identify and facilitate various problems and possibilities during import and export through the port.



Executive Committee members and Secretariat of Nepal Freight Forwarders Association had visited to Kakkarbhita dry port, Phulbari Port, major port by road and railway from Kolkata to identify the various problems, challenges and solutions of the Nepalese cargo and to inspect the current situation. During the visit, the Team met Heads of Kakkarvitta Port, Mechi Customs Office, Nepal Intermodal Transport Development Committee, Nepal Transit & Warehousing Company Ltd. and Senior representatives of Siliguri Border Customs Commission, Nepali Consulate General of Nepal to Kolkata, Chairman of Kolkata & Haldia Port, ASIC, NECHHA, CCHAA, CONCOR, journalists, customs agents, private container warehousing companies and related agencies and requested for the necessary initiatives for the promotion and facilitation of the Nepali logistics sector.



#### **Training/Seminar Report**

Association is providing different related education and training programs to its members, ensuring they are wellequipped with the knowledge and skills necessary to navigate complex international trade regulations. These initiatives often include workshops, seminars and certification programs focused on topics such as customs compliance, dangerous goods handling, documentation requirements and risk management.
